





#### **Our Staff**

Guiding Harbor staff provide both indirect and direct services. Indirect services help our business to operate, like administrative tasks, maintenance work or accounting. These people could take their talents to the for-profit world and make a lot more money and receive corporate perks. Instead, they chose to commit themselves to making a difference to children. There are also staff that provide direct services to the children and families in our care. Our staff spend time with Michigan's most vulnerable and try and make changes for the betterment of those we serve.


## **Foster Care**

Children enter foster care after abuse and/or neglect occur, and it is determined that the parent cannot safely care for the child. This is a legal process involving the courts. Foster Care Case Managers are assigned to help support the biological family through the process with the goal of returning the child back to the parent. Foster Care Workers, as they are sometimes called, also oversee the placement of the child in a licensed foster home or with a relative

The courts typically give the biological family 12- 18 months to resolve the matters that led to the removal and to prove that they can safely parent their children. Most children in foster care return home, but when that cannot safely occur in a reasonable amount of time, the court can terminate the parental rights, making the child eligible for adoption.



## Supervised Independent Living (SIL)



Teens are on the precipice of adulthood and need to learn skills that will help them be responsible adults. They must work or go to school and in return enjoy a level of autonomy they might not get in a foster home. They receive specific lessons on things like budgeting, household management, career and job readiness, and health management. Youth in this program have services to support them, which help them take responsibility for their own actions so they may have a successful transition into adulthood.



## **Adoption**

Harbor's Adoption Guiding program is the newest in the continuum of services, opened in 2019. This program supports families who are interested in adopting a child from Michigan's foster care system. A child in foster care becomes available for adoption when their parent's rights have been terminated by the Court. Most often, the foster parents or relatives who are caring for the child adopt them. The process of adoption is a legal one and takes 9-12 months.

Sadly, there are more than 200 kids in Michigan who are eligible for adoption today that do not have a family identified to adopt.



## Girlstown Residential

Girlstown is the flagship program our agency was founded upon. It is a place for teen girls in foster care to live when their traumatic past causes them to display behavioral problems. They typically live in residential for about a year while they work with our team to address their mental health and behaviors. The Girlstown program is structured to maintain the physical and emotional safety of the residents. The youth at Girlstown attend public school and participate in community activities and some even have jobs nearby. When they leave our program, most move back to a foster or adoptive home or on to independent living.



## **Foster Care**

Brittany has not had an easy life and she hasn't always made the best choices. In 2018, Brittany's son Josh came into foster care as a result. Six-year-old Josh was devwith her foster care worker. This made it difficult for the worker to advocate for her and help connect her to resources. Without regular communication, she was unable to be there for Josh consistently. As a result, Josh's challenging behaviors

astated when he was removed from his mom. He was able to live with his grandmother but the evidence of his traumatic past proved trying for her.

Brittany struggled to maintain stable housing and communication

escalated, and grandma could no longer keep him. Josh moved to live with Brittany's Aunt Rita. Maintaining the family connection was great for Josh, but Brittany and Aunt Rita did not have the best relationship. When Brittany tried, Aunt Rita was not always responsive. This in turn,

made Brittany not want to put in the effort.

At Guiding Harbor, we know that with the right kind of support families can evolve. We saw that with Brittany and in 2020, she started to put in the effort, with the support of her foster care worker. Brittany was able to find and maintain stable housing for the first time in years. She improved her communication skills and was visiting Josh steadily. In 2021, After 3 years apart, Josh and Brittany were officially reunited. The family received reunification services and their case was happily closed.



When Jasmine was 17 she had already been in foster care for 6 years. She was a foster kid, who was parenting her own toddler and expecting another child. A tall order for anyone! She had lived in countless foster homes and was eager to be out of the foster care system but was not ready to be on her own. She entered Guiding Harbor's Independent Living Program to help her evolve into adulthood.

Independent Living requires that the youth work and/or attend school to be eligible for services. This was a struggle for Jasmine. School had always been challenging, but during the pandemic, online schooling was even worse.

She also lacked confidence with being independent.. Due to her circumstances, she was eligible for many amazing resources but struggled to ask for help.

Jasmine had not only been able to help herself out by learning how to access community services or online schooling, but she was also showing her daughter that when

faced with challenges in your life, you are not stuck in your circumstances, you can evolve and grow.

Jasmine completed the Independent Living Program in 2021, when she turned 21 years old. She and her children are now living out of the foster care system.

## **Adoption**

Families evolve from a variety of beginnings, no two are alike. Joe and Lisa Cameron felt called to be foster parents. Having no children of their own, Lisa felt that her expe-

rience in being a nurse might to care for a child that had severe medical needs. Within days of becoming licensed, they got the phone call they had been waiting for. Georgia

was born addicted to drugs; she was preparing for discharge from the hospital and needed a foster home that could help support her extensive medical needs. She was tiny and had trouble eating which required a feeding tube and would need to go to many doctor appointments in the months and

maybe years to come. Joe and Lisa said yes!

After two years in foster care, Geor-

gia's biological parents were still unable to care for her. There was no likelihood that they would be able to offer her stability soon, so a judge terminated their parental

rights. Georgia was now available to be adopted. Joe and Lisa never planned to adopt, but now found themselves in love with two-year-old Georgia, who had been with them since birth. Without intention.

the Cameron's had evolved into a forever family. Joe, Lisa and Georgia became a family on 9/15/2021.



At 15 Amal was placed in foster care. She was relatively new to this country and spoke limited English. She was away from anything familiar, and she was frightened but when she arrived at Guiding Harbor's Girlstown residential program staff saw right away a glimmer in her eye. This glimmer was Amal recognizing that even though she was scared, this was an opportunity for her to forge her own path. She had a kind soul and a thirst to learn and so her journey began.

Amal quickly adapted her language skills and learned English. Girlstown's focus on life skills, therapy to help her overcome her trauma, and education in the local school system was just what Amal needed to grow into an independent person. While staying at Girlstown, she was able to really get the support that she needed at the time, which allowed her to have stability in her life.

Girlstown staff assisted Amal with college applications and helped her to practice her English. She graduated from high school and graduated from Girlstown. She then transitioned to Guiding Harbor's Independent Living program.

This allowed her to learn how to be on her own but still in an environment where she had assistance and support. The letter came one day telling her she had been accepted to Western Michigan University.

Amal applied for and received Guiding Harbor's Suzanne Baber Scholarship three times throughout her college career. This allowed her to be able to have financial assistance with her college education. Amal credits the scholarship

helping her achieve an education, "Even though money doesn't buy happiness, it can assist in a way that alleviates a large stressor in someone's life for them to have a chance at a good life." Amal received a bachelor's degree and a master's degree from Western Michigan University.

Amal currently works in higher education supporting college students who were in foster care. She enjoys what she does because not only does the program help students transition into college, but it also allows her to take her own experiences and aid those who are similar circumstances. Because of the generous donors who have given their assistance, she has been able to go to college and pass on her skills to the next generation. It was a ripple effect that she hopes can continue.

Guiding Harbor was able to assist Amal in many ways but in the end, it is Amal who deserves the credit. She took the skills that she learned and applied them to all the facets of her life. She used her past to fuel the dreams she had for herself. She accomplished her goals for education and now is using what she learned to help others achieve their dreams.

#### **Suzanne Baber Scholarship**

Suzanne Baber was past President of the General Federation of Women's Clubs - Lake Orion, of which she was an active 50 year plus, member. Suzanne was a teacher/counselor for Waterford Township High School and later Waterford Kettering High School.

She had her husband were active in promoting higher education. Thanks to her original donation, a scholarship fund was created in 2013 to encourage continuing education of persons who have successfully been released from the programs of Guiding Harbor. This scholarship has helped provide higher educational access to several former participants of Guiding Harbor's services. The Suzanne Baber Scholarship is perpetuated by the generosity of other like-minded individuals.




Meet Delores Redmond, the Youth Specialist Supervisor at Girlstown. Delores was born in Jackson, Mississippi and her family moved to Michigan when she was 5 years old. She graduated in 1978 from Miles College in Alabama with a Bachelor's in Social Work.

Delores has 4 adult children and 8 grandchildren, including 2 sets of twins. The oldest twins are graduating high school this year and her granddaughter will be attending Michigan State University in the Fall and will major in Social Work.

"Ms. Delores," how she is known to us, has more than 40 years of working in various types of residential programs in Michigan. She joined the Guiding Harbor family in 2015 and supervises the Girlstown residential program. Ms. Delores retired from Guiding Harbor in 2019, but she found her way back to us in 2020.

Delores has honed her craft of working with kids in residential. She is known to treat her team members and the youth she works with fairness and compassion. Delores has dedicated her career to helping children in the foster care system. Allison Theide, Youth Specialist said, "Ms. Delores has always been a blessing to me, and I adore her for it! She has so many strengths. Ms. Delores is invaluable to Girlstown. She leads by example and motivates us. I value her wisdom, support, teamwork, and I trust her completely. Staff can come to her with anything, and she provides us with genuine feedback."

Ms. Delores provides a safe and protective atmosphere for our youth. She meets them at their level and guides them in a way that they understand. She is an extra level of support for them, and they are grateful for her. She is also dedicated in training new staff and sharing her life experiences, so that they may learn from her failures and successes. Nikki Place,

Team Leader shared, "Working with Ms. Delores has been nothing short of amazing. She has taught me more about this job and field than I ever could have imagined. She has provided me with the tools and guidance that will help me in my current position and future positions for years to come. Her structure, firm hand, and guidance for the residents that we serve is something that they will take with them when they leave Girlstown and be able to learn from. Former residents have stated that this program, with Ms. Delores, have impacted them more than any other placement that they have been in."

Delores is an avid reader of mystery novels, specifically James Patterson. She has an extensive library and likes to attend book fairs to grow her collection. She also enjoys watching mystery movies on the Hallmark channel and Lifetime network. She plays Candy Crush and trivia games to relax. Delores is a treasured member of the Guiding Harbor Family; we are grateful for her her commitment every day.



Trauma is the response to a deeply distressing event that overwhelms a someone's ability to cope, causes feelings of helplessness, and their ability feel and express appropriate emotions. Some sources of trauma include abuse or neglect, being removed from your parents, siblings, home, school, friends and familiar surroundings. Girlstown has been a home to girls who have difficulty coping with their symptoms.

Ciara's mother had a long history of abuse and neglect allegations and when she was 11, Ciara was removed from her mom and put into foster care with her aunt. A few months later, the aunt reported that Ciara was having crying spells, would not listen to direction and was disruptive in her home. Ciara was assessed for

residential placement and was placed at Girlstown in May 2019, when she was 12 years old. During her initial months at Girlstown, Ciara continued to experience crying spells, she demonstrated disrespectful behaviors towards staff and did not want to attend school. Ciara was a follower and when her peers would act out, she would try and replicate the behavior.

Ciara received therapeutic and psychiatric services during her time at Girlstown. She was treated with therapy and medication to help improve her mood. Van Buren Schools assessed her for special education support and Ciara qualified for services. With the right kind of support, her attitude and behavior improved, she was evolving. She developed some positive relationships with her peers and staff members at Girlstown, which allowed her to progress through the level system and earn extra privileges. Ciara was having consistent visits with her brother during her time at Girlstown. In-person visitation





with her sisters was sporadic, but they were able to have phone and virtual visits.

After Ciara's parent's rights were terminated in 2019, she was available to be adopted. Adoptive

ing at Girlstown since she was in the program for 2 years. The staff and other residents were very supportive and encouraging to Ciara during her transition.

families were identified for Ciara, but twice they changed their minds. She was once hopeful but was building resentment toward the families and the system for letting her down.

In early 2021, a third adoptive family was identified for Ciara. She was excited to be placed in the foster home in April 2021. Ciara was nervous about no longer liv-

contact with Ciara and her foster family through monthly visits to assist with the transition and provide resources for any identified needs. Things were going well when services closed, but a month later, Ciara ran away from the foster home and called Girlstown. The staff at Girlstown helped contact the police and Ciara's foster care team at DHHS. Over the course of the next few days, it was deter-

mined that Ciara would not return to that foster home and no other foster homes were available for her. When Girlstown staff got the call and learned of her situation, they were happy to have Ciara come home.

The Girlstown residential program is highly structured, and it is led by a staff team that really cares about the youth placed with us. While most kids claim to hate the rules, they grow to rely on the consistency that is matched with care and empathy of staff. It is a safe environment for them to work through their trauma. Ciara has had a lifetime of disappointment in her 15 years of life. Creating real connections and trusting others is really hard for her. The Girlstown staff are committed to being reliable so that Ciara can learn to trust others. We believe that she will be ready for the right family one day. We are committed to cheering her on, all the way.

The Board of Directors is the governing body of Guiding Harbor. The individuals who sit on the board are responsible for overseeing Guiding Harbor's activities. A successful Board links its roles and duties not only to the other members on the board but also to our staff and our clients. The Board of Directors at Guiding Harbor is a Working Board, both responsible for the big picture strategy and polices, as well as helping to implement certain aspects of the work. Everyone has a part to play in making Guiding Harbor a sustainable agency.

Members of the Board are elected by the sitting directors at their Annual Meeting from a slate of culturally diverse candidates for a term of two (2) years and may be reelected. Board members meet five times per year to discuss and vote on the affairs of the organization.

#### What are the responsibilities of individual board members?

- As a board member you are part of the team that hires and oversees the Chief Executive Officer (CEO) of Guiding Harbor, maintains its financial integrity, monitors the agency's financial affairs, solicits contributions/donations, approves organizational policies and has general oversight of Guiding Harbors' business transactions.
- Members of the Board will all be asked to complete background checks yearly. This is done through the Agency at no cost to the board member. You will also be asked to fill out and sign a yearly Ethical Code of Conduct form.
- As a Board member you are expected to attend five full Board meetings each year either in person or virtually.
- When you are placed on a committee you will be expected to attend any and all committee meetings either in person or virtually, in addition to the scheduled full Board meetings.
- Each Board member is expected to participate in all fundraising events sponsored by the Board.
- Confidentiality in the Boardroom relates to board members' duty of loyalty to Guiding Harbor. Any issue that is not declared public information is to be kept confidential.


#### **Auditor's Opinion**

#### 2021 Expenses




#### **Allocated Costs**




